SEC.58-30: Exemptions and restricted uses. Loudspec	aker Sound Truck		
(20) Loudspeaker/public addresses systems. No person or entity shall cause, allow, or permit for any purpose any loudspeaker, public address system, or similar device that produces, reproduces, or amplifies sound, such that that sound there from exceeds the levels stated in Section 58-29 relative to the receiving property type without first obtaining a permit to do so. The permit shall be granted only for the amplification of music or human speech, or both, The Permit:			
 a. May be obtained by making application to the city. b. Requires payment of a \$10.00 fee for the administrat statement of inability to pay the fee. c. Is valid for one 14-hour period between hours of 8:00 d. Shall not be issued to the same or any other person of twice during any 30-day period. In a case of a sound area traversed by the truck in one day. e. Shall not authorize, allow, or otherwise permit the proposition sound that exceeds 65dBA when measured from the f. Requires an application containing the following information. 	O a.m. and 10:00 p.m. or entity for the same location more than truck, location shall relate to the coduction, reproduction, or amplification of property line of the nearest receiving property.
